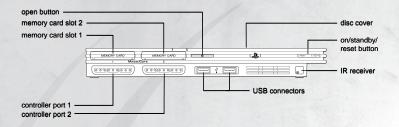

Getting Started



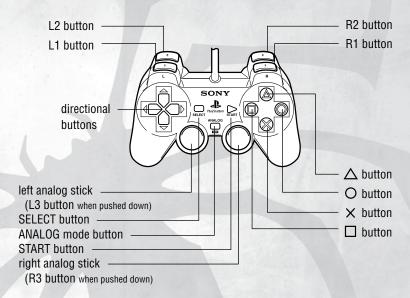

Navigating the Menus

Main Menu

New Game – This is where you begin a new *Spider-Man: Web of Shadows – Amazing Allies Edition* game. Selecting this will give you the option to select among three difficulty levels: Friendly, Amazing and Spectacular.

Load Game – Load your previous *Spider-Man: Web of Shadows – Amazing Allies Edition* save.

Options — Adjust the volumes of sound effects, music and voices. The credits can also be viewed from this menu. Options can be selected from the Ready Mission screen as well.

Ready Mission

Power-ups Manager – Manage the power-ups of Spider-Man.™

Skills Manager – Manage Spider-Man's skills. Also, spend your red or black points on suit-specific moves.

Start Mission – Begin the game.

Exit Game - Return to the Main Menu.

Basic Combat

Spider-Man will start the game with his basic attacks. As you progress through the game, points will be collected and then spent on the Skill Manager screen found in the Ready Mission menu.

Red and Black Choices

Throughout your adventure, Spider-Man will converse with many people, ranging from civilians, allies or the very villains he is trying to stop.
